## Consultation on the Draft North Claines Neighbourhood Plan and Strategic Environmental Assessment

Thank you for referring the above consultation, which we received on 4 November 2015.

For completeness, we provided comments to Wychavon District Council in relation to a consultation on the Strategic Environmental Assessment (SEA) Screening Opinion request and pre-submission draft of the Neighbourhood Plan.

Following this we sent a copy of our Neighbourhood Plan pro-forma guidance to the planning policy team at Wychavon District Council on 25 November 2015, for distribution to Parish Councils (as enclosed).
