Dear Mr Ford, Re Consultation Bredon Parish Submitted Neighbourhood Plan Regulation 16 Consultation Monday 4th July – Monday 15th August 2016

We write in connection with the current consultation on the draft Bredon Parish Neighbourhood Plan 2016-2030. We trust you have our previous letters and comments made to Bredon Parish Council, which together with this letter will be put before the examiner for consideration. We will remind you that Harriet Baldwin MP has also written to Jack Hegarty about this issue for us.

We write to oppose the designation of LGS1 as Local Green Space. We are owners of the land in question.

Paragraph 77 of Nation Planning Policy Framework makes it clear that designation of an area as Local Green Space should only be used where the green area is demonstrably special to a local community and holds a particular local significance, for example because of its beauty, historic significance, recreational value, tranquillity or richness of its wildlife. The land is pasture land. It is no different from any other area of pasture land surrounding the village. No evidence has been submitted that the land is demonstrably special to the local community in the manner required by the National Planning Policy Framework or otherwise.

The land is already within an Area of Outstanding Natural Beauty. Paragraph 11 of Planning Practice Guidance 37 specifies that if land is already protected by designation then consideration should be given to whether any additional local benefit would be gained by designation as Local Green Space. There is no evidence of any such consideration having been given. We submit that by reason of the land being within an AONB, no additional local benefit will be gained by designation as Local Green Space as well.

We submit therefore that the proposed designation as Local Green Space should not be accepted.
