Page 37 NP13: Local Green Space and policy 7.45

Please use the space below to make comments on this part of the Neighbourhood Plan.

I have raised this point several times with the Parish Council, and it has been dismissed, yet I have a strong opinion that the omission of the land between Oak Lane and Farm Lane as Local Green Space in the Bredon Neighbourhood Plan conflicts with the paragraph 7.45 Quote - 'This policy designates and protects green areas or open space within and adjoining built up areas as Local Green Space. These are areas which are demonstrably special to the local community and hold a particular local significance, for example because of their beauty, historic significance, recreational value, tranquillity or the richness of their wildlife.'

The parcel of land between Oak Lane and Farm Lane lies immediately to the south of the Development Boundary but is included in the Conservation Area. The reason for it's inclusion in the Conservation Area is outlined in Bredon Conservation Area Appraisal 2008 (Wychavon Council) Quote - 'Extensive ridge and furrow is evident in 1947 aerial photographs although most has since been ploughed out and little remains today. A surviving remnant at the southern fringe of the village, between Oak Lane and Farm Lane, is the only tangible reminder in the village of this period of early settlement activity in its history and is an important feature of the conservation area.'

Therefore this area which does lie 'within and adjoining built up areas', clearly is of local and historical significance (because Wychavon have defined it as such) and should be included as Local Green Space in the Bredon Neighbourhood Plan.



There are omissions in the list of identified key views in the Neighbourhood Plan. It is only partly compatible with those shown on the plan with the 2008 Conservation Area appraisal (Wychavon 2008).

The Conservation Area was significantly extended southwards to include the land between Oak Lane and Farm Lane, Bredon. In doing so a significant view was identified from the high point at the top of Oak Lane looking northwest across the village (see plan below). I believe this, and other views, should also be included in the list of views in the Neighbourhood Plan.
