### **Summary**

Following an independent examination, Wychavon District Council now confirms that the Cleeve Prior Neighbourhood Plan will proceed to a Neighbourhood Planning Referendum on Thursday 1 February 2018.

#### **Background**

On 28 May 2013, Wychavon District Council designated the area comprising the Parish of Cleeve Prior as a Neighbourhood Area for the purposes of preparing a Neighbourhood Plan.

Extensive community consultation culminated in the draft Cleeve Prior Neighbourhood Plan consultation which took place in May and June 2015. The consultation responses fed into the final version of the Cleeve Prior Neighbourhood Plan which was submitted to Wychavon District Council in April 2017, along with the associated Basic Conditions Statement, Consultation Statement and SEA Report.

The Cleeve Prior Neighbourhood Plan and associated documentation was then publicised and representations were invited. The publicity period ended on 14 June 2017.

Wychavon District Council appointed an independent Examiner, Nigel McGurk of Erimax Ltd, to review whether the Plan should proceed to referendum in July 2017.

Having considered each of the recommendations made by the Examiner's report and the reasons for them, in consultation with the Parish Council, Wychavon District Council has decided to make the modifications to the draft Cleeve Prior Neighbourhood Plan as detailed in Table 1 below in order to ensure the Plan meets the Basic Conditions as set out in the legislation.

#### **Decisions and Reasons**

Wychavon District Council has made the following modifications, as proposed by the examiner and agreed by the Parish Council, to ensure that the Cleeve Prior Neighbourhood Plan meets the Basic Conditions.
