Policy 4.2: Environment and heritage

The Herefordshire and Worcestershire Earth Heritage Trust is a charity that aims to record, protect and promote geology and landscape in the two counties. We identify sites of geological interest and advise the County Councils on any plans that may impinge upon them.

There are no known Sites of Geological Interest within the Harvington Neighbourhood Area, and hence we are happy with the planning proposals.

The geology of the area however is quite diverse: the bedrock in the eastern part consists of early Triassic, Mercia Mudstone, while that in the West is late Triassic to Jurassic Blue Lias and Charmouth Mudstone. The fault where this change occurs runs right through the village. Further, the action of the Avon RIver in more recent times has alternately cut through the bedrock and deposited a series of three different river terraces within the area of the plan.

The Trust is always interested to learn more about the geology of the two counties and temporary excavations created by building work can give us the opportunity to do that. As there are virtually no accessible rock exposures in the Vale of Evesham currently, we would be very interested in investigating any that might arise as a result of work in the Harvington Area.

We could also work with local people to produce some graphical images of the geology of Harvington and to see what links we can make between topography, soils and the geology, if that is of interest.
